This draft Energy Storage Strategy and Roadmap (SRM) update conforms to the language set forth in the "Energy Storage System Research, Development, and Deployment Program" as required by the Better Energy Storage Technology (BEST) section of the Energy Policy Act of (42 U.S.C. 17232 (b) (5)).
