Who owns Greece's battery storage and solar PV projects? UK-headquartered investment management group NextEnergy Capital has acquired six standalone battery storage and six solar PV projects in Greece. The acquisitions have been made by NextPower ESG III, a private solar fund managed by NextEnergy Capital to invest in the OECD region.

How many MW of new battery storage capacity does Greece have? The Greek authorities have awarded 300 MW of new battery storage capacity in its second energy storage tender. The 11 winning projects range in size from 8.875 MW/17.75 MWh to 49.9 MW/100 MWh.

Does Greece have a 1 GW energy storage program? The auction is part of Greece's 1 GW energy storage program. The country announced its 1 GW energy storage program in the summer with three separate tenders featuring 400 MW, 300 MW and 300 MW of capacity. The first tender awarded 12 energy storage projects in August, with 411,79 MW of capacity in total.

How many MW of storage will Greece need by ? The majority of the projects (2,650 MW) belong to Group G and will connect to ADMIE as follows per region. A key factor driving companies is that this large capacity will cover all the storage needs Greece will require by .
