



## tripoli energy storage subsidy policy latest announcement

Overseas media news on December 5, Italy's Minister of Enterprise and Manufacturing Adolfo Urso signed a new decree that will provide 320 million euros in energy subsidies to support small and medium-sized enterprises (SMEs) to invest on their own in the development and utilization of renewable energy sources, with the aim of increasing the self-generation and self-consumption rate of photovoltaic or small-scale wind power, in order to reduce the dependence on foreign energy sources.
